## **Move Out Check List**

	Yard recently mowed and all weeds removed.
	_ Lawn watered and green, if it has been neglected a quote to revive it will be obtained from a professional lawn service and deducted
	from your security deposit.
	_ All Animal droppings have been removed. <b>Do Not Leave Anything Behind.</b>
	_ Trash and debris removed from premises. Do Not Leave Anything Behind.
	_ Clean up any oil spots left in garage if applicable. The garage must be cleaned of all debris, cobwebs, and dust. Please double check!
INSIDE	
	_ Carpet professionally cleaned by a truck mounted steam cleaning vendor and receipt provided. If you have pets and a pet treatment is
	required ensure you discuss this with your carpet cleaning vendor.
	_ House cleaning to include:
	_ Clean the refrigerator, which includes defrosting, washing completely inside and out.
	_ Clean outside door of dishwasher and inside which includes any buildup of impurities along stripping and throughout the dishwasher.
	_ Clean entire range and vent hood: including oven, stovetop, under burners and rings, drip pans, bottom drawer and washing outside.
	Clean inside of windows, window sills, glass, mirrors, glass doors, and dust blinds.
	_ Wipe down all doors inside and out. Don't forget along the top of the door and door frames. Don't forget the closets and closet shelves
	Clean out fireplace and any area surrounding the fireplace. If it is a wood burning fireplace it must be cleaned out.
	_ Wash down walls in kitchen and bathrooms as well as any marks in any other room. All bathroom cabinets and drawers must be cleaned
	_ Vacuum the carpet and sweep and mop the vinyl, wood floors or titles. Make sure your mob is clean and does not leave streaks.
	Dust ceiling and corners for cobwebs. Dust; wipe down baseboards heaters, light fixtures, ceiling fans, bathroom fans and the vents.
	Dispose of trash. Do Not Leave Anything Behind To Be Picked Up, Disposed of or Hauled Away.
	CO detectors installed by All County Property Management must be left in property.
	Change AC and furnace fliers.
	Replace "all" hurned out hulbs

- Request a final meter reading for utility services. Don't forget to cancel all newspapers subscription, and send the post office a change of

  OWNERS NAME\*
- Once you have cleaned your residence and removed all your belongings, please call the office at **719-445-7172** to arrange for a time to return all keys and remotes.
- Please be prepared to give us your forwarding address where we may mail your security deposit. The Security deposit will be returned within 30 to 60 days per the arrangement stated on the rental agreement. If any deductions are made (for past due rent, outstanding invoices or because the residence is damaged or not sufficiently clean), they will be explained in writing per Colorado State Law.
